CONTRACT FOR USE OF FACILITIES

**1. The undersigned requests approval to use Fort Roberdeau facilities as described below.**

By signature of this Contract by the user's designated official, the user (1) verifies that all Contract information is correct and (2) agrees to review and abide by the Hold Harmless Agreement and the Rules for Use of the Site established by the Blair County Commissioners, the Fort Roberdeau Association Board and the Executive Director.

**2. The Contract including the Hold Harmless Agreement must be signed prior to use.**

The purpose of the Hold Harmless Agreement is to release the County Commissioners, the Fort Roberdeau Association and its Board of Directors, the Executive Director and the Staff from being liable for any mishap which occurs related to the usage of the Fort Roberdeau facilities during the contract period.

**3. The Security Deposit is due upon reservation. (\$100 refundable deposit)**

It shall guarantee availability and will be returned after use, minus the cost of any items missing or damaged as determined by site inspection after use. If the contract is canceled within two weeks before the scheduled usage, only one-half of the Security Deposit shall be returned.

**4. The User Fee is due in advance of the use of the facilities. (\$200 nonrefundable fee)**

The undersigned further hereby agrees to indemnify and hold harmless the County of Blair and the Blair County Commissioners, the Fort Roberdeau Association and its Board of Directors, the Site's Executive Director and Staff and all other persons employed by and of the aforesaid, with respect to any claim, action, demand, loss, expense, liability (joint or several), penalty and other damage, including without limitation, counsel fees and other costs and expenses incurred to avoid or oppose the imposition of damages by any their party as a result of the use of the Fort Roberdeau Facilities.
